CALL MEETING TO ORDER

Mayor Pyle called the meeting to order at 12:00 p.m.

ROLL CALL

PLEDGE OF ALLEGIANCE

ACCEPTANCE OF THE AGENDA

Motion by Huston, seconded by DeLange to accept the agenda as presented.

PUBLIC FORUM

REGULAR BUSINESS

- A. Consider bids for having at the lagoons
 - Mayor Pyle opened one bid by Derek Delange to crop shares 2/3 to self and 1/3 to City of Girard at \$70.00 per ton and scale ticket will be provided with payment to the City
 - Motion by DeLange, seconded by Leslie to accept the proposed bid for having. Motion carried
- B. Consider quote for primary underground wire for Electric Department
 - Several quotes were provided to the council regarding primary underground wire from Border States, Anixter and Stanion.
 - Motion by DeLange, seconded by Stansbury to accept the bid in the amount of \$22,500 from Anixter for primary underground wire. Motion carried.
- C. Consider HSA option
 - Motion by DeLange, seconded by Huston to accept the HSA at GNBank at no
 cost to the city and offer to employees Option C with HSA contribution from the
 city to equal the difference in savings from Option A to Option C. Motion
 carried.
- D. Consider opening Court for August

Tim Fielder, City Judge, was present to express his concerns regarding court, including social distancing, face mask and a maximum of people allowed in the courtroom. The council asked the City Attorney, Steve Angermayer, his opinion

- Motion by DeLange, seconded by Leslie to give the City Administrator authority to get information to he council in order to make a decision. Motion carried.
- E. Consider releasing RFQ for water and wastewater improvements
 - Motion by Stansbury, seconded by Huston to Table the RFQ for water and wastewater improvements until August 3, 2020. Motion carried.
- F. Executive session for nonelected personnel to discuss pay for employee working in two departments and health insurance
 - Motion by Leslie, seconded by DeLange to go into a 15-minute executive session to include Mayor, Council, Electric Department Director, City Clerk, City Administrator and City Attorney to discuss nonelected personnel for an employee working in two departments. Motion carried.
 - Mayor Pyle returned to regular session following the 15-minute executive session.
 - Motion by DeLange, seconded by Leslie to pay Jacob Jones \$16.00 per hour while working at the power plant. Motion carried.
